## **Memorandum of Incorporation (MOI)**

A company's MOI or rules are binding. In this module, you will understand the various relationships between the company and each shareholder and amongst the shareholders of the company. It also addresses the relationship between the company and directors or prescribed officers in the exercise of their respective functions within the company, between the company and members of the audit committee or any other committee of the Board in the exercise of their respective functions within the company.

Corporate governance, for the purposes of King IV<sup>TM</sup>, is defined as the exercise of ethical and effective leadership by the governing body that results in the achievement of the following governance outcomes: An ethical culture, performance and value creation, effective control and legitimacy.

## Different role players

Although it is correct to assume that the role of a director carries with it substantial power and authority, the flip side of the coin to also keep in mind is accountability and potential personal liability, whether financial, reputational or both. Complying with the law and ensuring that appropriate corporate governance is practiced in a company will assist a director in being effective and limiting the risk of personal liability.






